1 DECISION

Having completed a review of the application, the Alberta Energy and Utilities Board (EUB/Board) hereby approves Application No. 1366860.

2 INTRODUCTION

2.1 Application

APF Energy Inc. (APF) applied to the EUB pursuant to Section 2.020 of the *Oil and Gas Conservation Regulations* for a licence to drill a vertical well from a surface location at Legal Subdivision 11 of Section 12, Township 38, Range 27, West of the 4th Meridian. The maximum hydrogen sulphide (H₂S) concentration of the well would be 0.00 mol/kmol (0 per cent). The purpose of the well would be to obtain gas production from the Edmonton Group.

2.2 Intervention

Michael Eckenswiller (the intervener) is the landowner of the northwest quarter of Section 12-38-27 W4M. The intervener filed an objection to this application in November 2004.

2.3 Hearing

The Board was scheduled to hold a public hearing in Red Deer, Alberta, on June 9, 2005, before Board Member T. M. McGee (Presiding Member), Board Member J. R. Nichol, P.Eng., and Acting Board Member E. A. Shirley, P.Geol. The hearing was cancelled by the EUB for the reasons set out in the discussion below.

3 DISCUSSION

APF and the intervener engaged in the EUB's Appropriate Dispute Resolution (ADR) program. On April 26, 2005, a signed withdrawal of objection from the intervener was received by the EUB. As there were no other objections submitted to the EUB, the hearing was cancelled.
