1 DECISION

Having received Application No. 1388043, noting that it meets AEUB requirements, and noting the receipt of a confirmation of nonobjection from interested parties, the Alberta Energy and Utilities Board (EUB/Board) hereby approves Application No. 1388043.

2 INTRODUCTION

2.1 Application

Canadian Natural Resources Limited (CNRL) applied on February 24, 2005, to the EUB, pursuant to Section 2.020 of the *Oil and Gas Conservation Regulations*, requesting approval to drill a vertical well from a surface location in Legal Subdivision (LSD) 4 of Section 29, Township 50, Range 13, West of the 4th Meridian. The maximum hydrogen sulphide concentration of the well would be 0.00 moles per kilomole. The purpose of the well would be to obtain crude oil production from the Banff Formation. The proposed well would be located approximately 33 kilometres northeast of Hanna.

2.2 Intervention

The Storches (the interveners) are the landowners of the southwest quarter of Section 29-34-13W4M and reside on the southwest quarter of Section 20-34-13W4M. The interveners filed an objection on March 10, 2005, raising concerns with respect to safety, construction, future facility development and production change, livestock, location and access, weed control, the environment, and reclamation and remediation.

2.3 Hearing

The Board was scheduled to hold a public hearing in Hanna, Alberta, on August 17, 2005, before Board Member G. J. Miller (Presiding Member) and Acting Board Members W. G. Remmer, P.Eng., and E. A. Shirley, P. Geol.

3 DISCUSSION

CNRL and the Storches met on July 15, 2005. The meeting resulted in the Storches withdrawing their objection to CNRL's application and on July 19, 2005, a signed confirmation of non-objection was received by the EUB. As there were no other objections submitted to the EUB, the hearing was cancelled.
