An error appears in *Decision 2005-116*, issued by the Alberta Energy and Utilities Board (EUB/Board) on November 15, 2005. The error appears on page 1, Section 2.1 of the report. This error correction is reflected in the decision that appears on the EUB Web site.

The original published decision read:

The pipeline would be about 1.62 kilometres (km) in length, with an outside diameter of 88.9 millimetres, and would transport sweet natural gas (that is, gas containing no hydrogen sulphide).

It now reads:

The pipeline would be about 1.62 kilometres (km) in length, with an outside diameter of 88.9 millimetres, and would transport oil effluent with 3 moles per kilomole (mol/kmol) (0.3 per cent) hydrogen sulphide (H<sub>2</sub>S).

### 1 DECISION

Having completed a review of the application, the Alberta Energy and Utilities Board (EUB/Board) hereby approves Application No. 1405826.

### 2 INTRODUCTION

#### 2.1 Application No. 1405826

ConocoPhillips Canada Resources Corp. (ConocoPhillips) submitted an application to the EUB on June 20, 2005, in accordance with Part 4 of the *Pipeline Act* for approval to construct and operate a pipeline for the purpose of transporting natural gas from an existing well located at Legal Subdivision (LSD) 9, Section 29, Township 40, Range 4, West of the 5th Meridian (the 9-29 well) to an existing satellite at LSD 8-28-40-4W5M. The pipeline would be about 1.62 kilometres (km) in length, with an outside diameter of 88.9 millimetres, and would transport oil effluent with 3 moles per kilomole (mol/kmol) (0.3 per cent) hydrogen sulphide (H<sub>2</sub>S). The proposed pipeline would be located about 20 km northwest of Eckville.

#### 2.2 Intervention

James Lawton holds a grazing lease for the northeast quarter of Section 29-40-4W5M, the parcel on which the 9-29 well is located, which the proposed pipeline would serve. He filed an objection to the application, which was received by the EUB on July 14, 2005. In his letter, Mr. Lawton cited concerns regarding operational matters at an existing ConocoPhillips facility located at LSD 10-35-40-4W5M. He did not raise any concerns about the specific application under consideration by the EUB.

### 3 DISCUSSION

On September 8, 2005, the EUB issued a letter, pursuant to Section 26 of the *Energy Resources Conservation Act*, to Mr. Lawton via registered mail. The purpose of the letter was to provide Mr. Lawton with the opportunity to identify concerns specific to Application No. 1405826 and to indicate how he may be directly and adversely affected by the approval of the application. The EUB outlined within the letter that a response was required no later than September 29, 2005, and that if a response was not received, the EUB would take that to mean that Mr. Lawton did not object to Application No. 1405826.

No response was received from Mr. Lawton by the specified deadline or to date. The Board proceeded with its consideration of the application and found that Mr. Lawton would not be

directly and adversely affected by the approval of the application. Accordingly, and because it meets the Board's requirements, the Board has approved the application.
