1 Recommendation

Having considered the application, and in accordance with Section 20 of the Alberta Energy and Utilities Board (EUB/Board) *Rules of Practice*, the examiner panel recommends that the Board accept the request by Blue Mountain Energy Ltd. (Blue Mountain) to withdraw Application No. 1404139.

2 Introduction

2.1 Application

Blue Mountain applied to the EUB, pursuant to Section 33(1) of the *Oil and Gas Conservation Act*, for a change in the pool designation of the 100/06-09-85-08W6M well (6-9 well) to accurately reflect its production of petroleum and natural gas from the Doig Formation, which Blue Mountain owns the rights to.

2.2 Intervention

An intervention was filed by PrimeWest Gas Corp. (PrimeWest) with its technical rationale as to why PrimeWest should have the right and ability to produce the 6-9 well. PrimeWest is the licensee and operator of the 6-9 well. An additional submission was received from Bonavista Energy Trust in support of the application by Blue Mountain.

3 Discussion

The EUB Law Branch sent a letter dated August 8, 2005, to all parties involved requesting additional information and notifying the parties that the application submitted for a change in pool designation was more specifically a request to change the zone designation for the subject well.

On November 30, 2005, a letter was received by the EUB from Legal Counsel for the applicant withdrawing the application.

The examiners are satisfied that no further action is required by the EUB and acknowledge the withdrawal of the application.
