### 1 DECISION

Pursuant to Section 20 of the *Alberta Energy and Utilities Board Rules of Practice*, the Alberta Energy and Utilities Board (EUB/Board) hereby accepts Questerre Energy Corporation's (Questerre) request to withdraw Application No. 1454960.

### 2 INTRODUCTION

#### 2.1 Application

Questerre applied to the EUB, pursuant to Section 2.020 of the *Oil and Gas Conservation Regulations*, for a licence to drill a vertical sweet gas well from a surface location at Legal Subdivision 16 of Section 12, Township 62, Range 2, West of the 4th Meridian. The purpose of the well would be to obtain gas production from the Belly River Group.

#### 2.2 Intervention

Cyre Seed Farms Ltd., owned by Cliff Cyre and Ida Cyre, the owners of the land where the proposed well was to be located, filed an intervention in opposition to the granting of the subject well licence application.

#### 2.3 Hearing

The Board was scheduled to hold a public hearing in Westlock, Alberta, on August 29, 2006, before Board Members J. R. Nichol, P.Eng. (Presiding Member) and J. D. Dilay, P.Eng., and Acting Board Member C. A. Langlo, P.Geol. The hearing was cancelled by the Board for the reasons set out below.

### 3 DISCUSSION

Subsequent to the Board's issuance of a Notice for Hearing, discussions continued between the parties, resulting in an agreement. On August 1, 2006, the Board received a signed withdrawal of objection from Cyre Seed Farms Ltd. for the proposed well location based on a revised access road to the well site. Questerre has requested that it be allowed to withdraw the current application as it plans to reapply for a well licence for this location with the revised access road in fall 2006, following completion of a new survey and confirmation of all associated crossing agreements and nonobjections from affected parties.
