**1 DECISION**

Having completed a review of the application, the Alberta Energy and Utilities Board (EUB/Board) approved Application No. 1474297 on April 13, 2007.

**2 INTRODUCTION**

**2.1 Application**

Crew Energy Inc. (Crew) submitted an application in accordance with Part 4 of the *Pipeline Act* for approval to construct and operate a pipeline for the purpose of transporting natural gas from Legal Subdivision (LSD) 9, Section 22, Township 53, Range 11, West of the 5th Meridian, to a pipeline tie-in point at LSD 1-23-53-11W5M. The proposed pipeline would be about 1.71 kilometres (km) in length, with a maximum outside diameter of 114.3 millimetres. The natural gas would not contain hydrogen sulphide. The proposed pipeline would be located about 9 km northwest of MacKay.

**2.2 Intervention**

Geza Szucs and Kristine Lange own and reside on the southeast quarter of Section 23-53-11W5M, where a portion of the pipeline was proposed. They filed an intervention stating various concerns regarding the proposed pipeline.

**3 DISCUSSION**

Crew engaged in one-on-one discussions with Mr. Szucs and Ms. Lange on April 2, 2007. The meeting resulted in an agreement between the parties, and on April 4, 2007, a signed withdrawal of objection was received by the EUB.
