1 DECISION

Having received Application No. 1615297, noting that it meets Energy Resources Conservation Board (ERCB/Board) requirements, and noting the receipt of a confirmation of nonobjection from the intervening party, the Board hereby approves Application No. 1615297.

2 INTRODUCTION

2.1 Application

Bumper Development Corporation Ltd. (Bumper) applied, pursuant to Part 4 of the *Pipeline Act*, for a licence to construct and operate a pipeline for the purpose of transporting natural gas with no hydrogen sulphide from Legal Subdivision (LSD) 4, Section 11, Township 31, Range 25, West of the 4th Meridian, to LSD 1-10-31-25W4M. The length of the proposed pipeline would be about 0.53 kilometres (km), with an outside diameter of 114.3 millimetres. The proposed pipeline would be located about 4.6 km northeast of the Town of Linden.

2.2 Intervention

Kevin Neufeld and Lenore Neufeld (the Neufelds), owners of land where a portion of the proposed pipeline would be located, filed objections dated January 20, 2009, and June 18, 2009. The Neufelds raised concerns about pipeline routing, safety, interference with farming practices, the environment, and property values.

3 DISCUSSION

Bumper engaged in field facilitation with Mr. Neufeld on August 27, 2009. The meeting resulted in an agreement between parties, and on September 22, 2009, a signed withdrawal of objection was received by the ERCB. As a result, the ERCB will not be scheduling a public hearing on this application.
