1 DECISION

The Energy Resources Conservation Board (ERCB/Board) hereby approves Applications No. 1653996, 1618077, 1623426, and 1679184, noting that they meet ERCB requirements, and noting the receipt of a confirmation of nonobjection from the intervening parties for Applications 1653996, 1618077, and 1623426.

2 APPLICATIONS

EnCana Corporation (EnCana) applied to the ERCB in accordance with Section 2.020 of the *Oil and Gas Conservation Regulations (OGCR)* for two wells at Legal Subdivision (LSD) 3, Section 2, Township 28, Range 23, West of the 4th Meridian and LSD 5-2-28-24 W4M. There would be no hydrogen sulphide (H₂S) associated with these wells.

EnCana also applied, in accordance with Part 4 of the *Pipeline Act*, for three pipelines for the purposes of transporting natural gas. The first pipeline would run from the proposed well located at LSD 5-2-28-24W4M to a pipeline tie-in point at LSD 2-3-28-24W4M. The second pipeline would run from the proposed well at LSD 5-2-28-24W4M to a pipeline tie-in point at LSD 3-2-28-24W4M. The third pipeline would run from the proposed well at LSD 3-2-28-24W4M to a pipeline tie-in point at LSD 2-2-28-24W4M. There would be no H₂S associated with these pipelines.

Ethel Jasman, Amber, Twyla, Berwyn, Cole, and Blain Tucker (the Tuckers) filed an objection to the applications.

3 DISCUSSION

The Board scheduled a public hearing in Acme, Alberta, to be held on December 15, 2010, before Acting Board Member G. J. Miller (Presiding Member), Board Member G. Eynon, P.Geol., and Acting Board Member D. J. Turner.

On November 25, 2010, the ERCB received a signed withdrawal of objection from Blain Tucker on behalf of the Tuckers. On December 6, 2010, the ERCB was informed by EnCana that it was still in discussions with the Tuckers over the routing of the pipeline running from LSD 5-2-28-

24W4M to 3-2-28-24W4M. Accordingly, the ERCB issued a Notice of Postponement of Hearing until it could be determined whether or not a hearing would be required.

On February 10, 2011 EnCana submitted Application 1679184, which replaced Application 1652131. The new application included the amended pipeline routing that was agreed upon by Ethel Jasman, who is the resident and life-estate owner for the SW of Section 2-28-24W4M. Notice for Objection for the new application was sent to Mr. Blain Tucker on February 10, 2011, and March 24, 2011, to ensure that he had no concerns with the proposed routing. Both Notices went undelivered and were returned to the ERCB. On April 1, 2011, Mr. Tucker left a message with ERCB staff indicating that he had been out of town and requested that all correspondence relating to Application 1652131 be re-sent. On April 5, 2011 the ERCB re-sent the first two Notices for Objection to Mr. Tucker, which were picked up on May 5, 2011. There was no further response or objection from Mr. Tucker.

Accordingly, the public hearing was cancelled.
