## **1 DECISION**

The Energy Resources Conservation Board (ERCB/Board) has accepted the request from Just Freehold Energy Corp. to withdraw Application No. 1601368 and cancel the public hearing scheduled to consider the application.

## **2 INTRODUCTION**

### **2.1 Application**

Just Freehold Energy Corp. (Just Freehold) applied to the ERCB for a licence to drill a vertical natural gas and coalbed methane well from a surface location at Legal Subdivision (LSD) 10 of Section 35, Township 37, Range 27, West of the 4th Meridian. The purpose of this well would be to obtain gas from the Edmonton Group and coalbed methane from the Horseshoe Canyon Formation, neither of which would contain hydrogen sulphide.

### **2.2 Interventions**

John Brett is the landowner of the proposed well site. Mr. Brett's objections were based on environment, location, land values, and liability. Randy Dyck and Suzanne Dyck are adjacent landowners. Their objection was based primarily on the location of the access road in relation to their property, in addition to concerns about water wells, flaring, noise, environment, air quality, and development timelines.

## **3 DISCUSSION**

On July 8, 2009, Just Freehold notified the ERCB that it was withdrawing Application No. 1601368, pursuant to Section 21 of the *Energy Resources Conservation Board Rules of Practice*, and the Board accepted the withdrawal of the application. Accordingly, the application was withdrawn and the public hearing previously scheduled to consider the application was cancelled.
