WHEREAS the Company was issued Enforcement Order No. EO-2014-02-UAR (the "Enforcement Order") on March 14, 2014;

WHEREAS the Enforcement Order was amended on March 21, 2014 (Amendment No. 1);

WHEREAS the Enforcement Order was further amended on March 26, 2014 (Amendment No. 2);

WHEREAS the Enforcement Order was further amended on June 19, 2014 (Amendment No. 3);

WHEREAS the Company has restricted access to Yellowhead Tower Pond 5 and Yellowhead Tower Pond 10 as the result of an unresolved blasting incident that took place on February 04, 2014;

WHEREAS the Company requires a further extension of time relating to the provision of engineering drawings under clause 2(a), for the assessment of drainage ditches under clause 2(c) and the scheduled retrofitting under clause 2(g) of the Enforcement Order.

WHEREAS section 212(1)(a) of the *Act* states that the Director may amend a term or condition of a enforcement order;

THEREFORE, I, Brian Olson, Director (Acting), pursuant to section 212(1)(a) of the *Act*, DO HEREBY ORDER:

1. Amend the date at the end of clause 2(a) to: **October 31, 2014.**
2. Amend the date at the end of clause 2(c) to: **October 31, 2014.**
3. Amend the date at the end of clause 2(g) to: **October 31, 2014.**
